

Dinner Hill Wind Farm Project Information Sheet

November 2025



The Project

OX2 is planning the Dinner Hill Wind Farm with approximately 160 turbines across a project area of 32,500 hectares. The site is located within the Hill River and Badgingarra localities approximately 26 km north of Dandaragan and 25km east of Jurien Bay, on private land.

The Project is proposed to connect directly to the 330kV Neerabup to Eneabba transmission line, which traverses the site, via a terminal station proposed to be located within the project area.

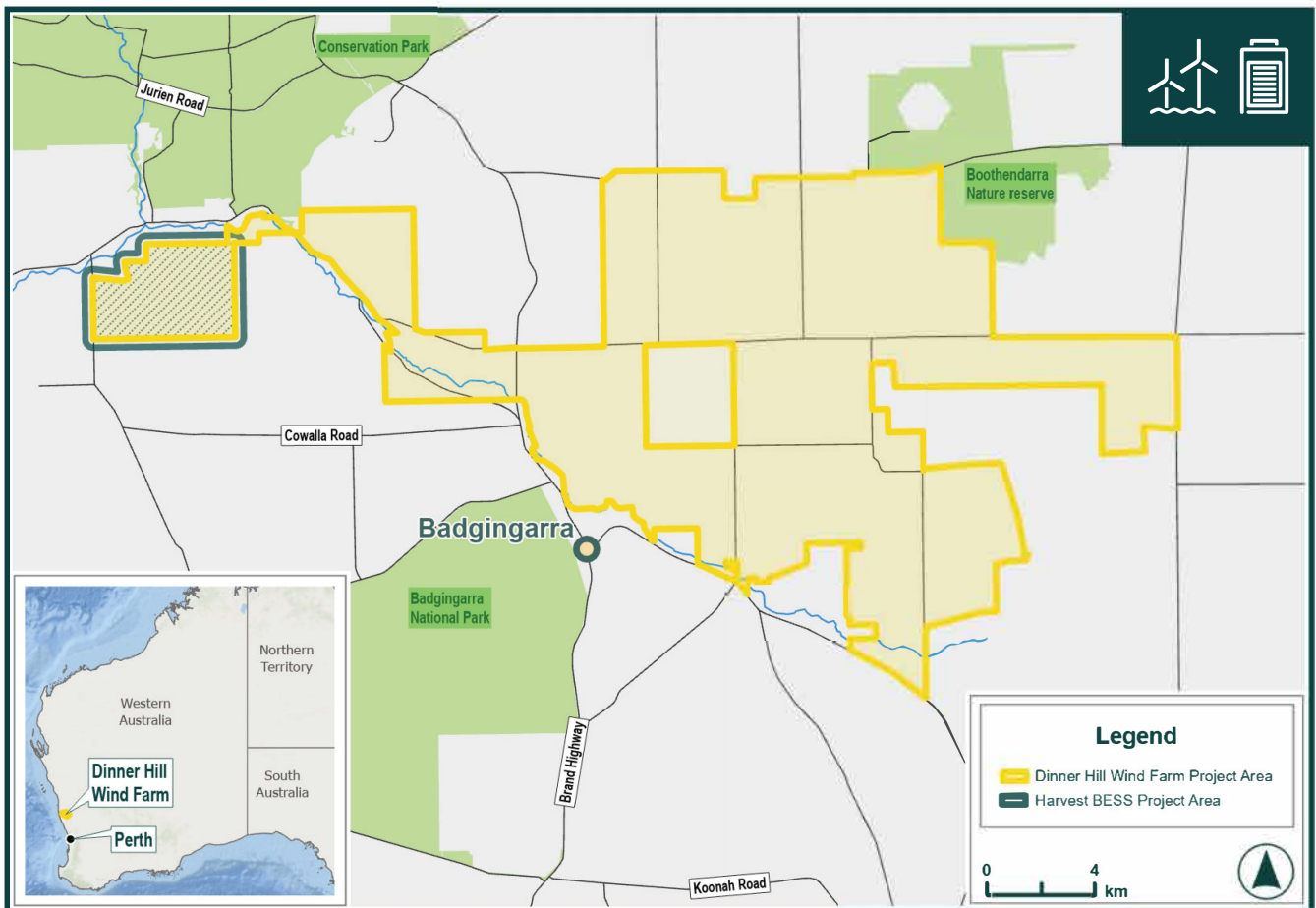
The Dinner Hill Wind Farm will likely include an ancillary Battery Energy Storage System (BESS) to support the wind farm and discharge clean energy when it is needed most. The size of the BESS will be confirmed once further technical assessments are undertaken.

Project Benefits

The Project is expected to deliver affordable, clean and reliable electricity for Western Australia while offering economic, social and environmental benefits, including:

- Powering approximately 763,000 WA homes with clean energy.
- Creating procurement and employment opportunities during construction and operations.
- A community benefit program which will be developed in consultation with the community.
- Reducing, on average, 3-4 million tonnes of CO₂ emissions annually.
- Supporting Australia's targets of 82% renewable energy by 2030 and Net Zero by 2050.

The Dinner Hill Wind Farm project area is co-located with the project area of OX2's proposed Harvest BESS.



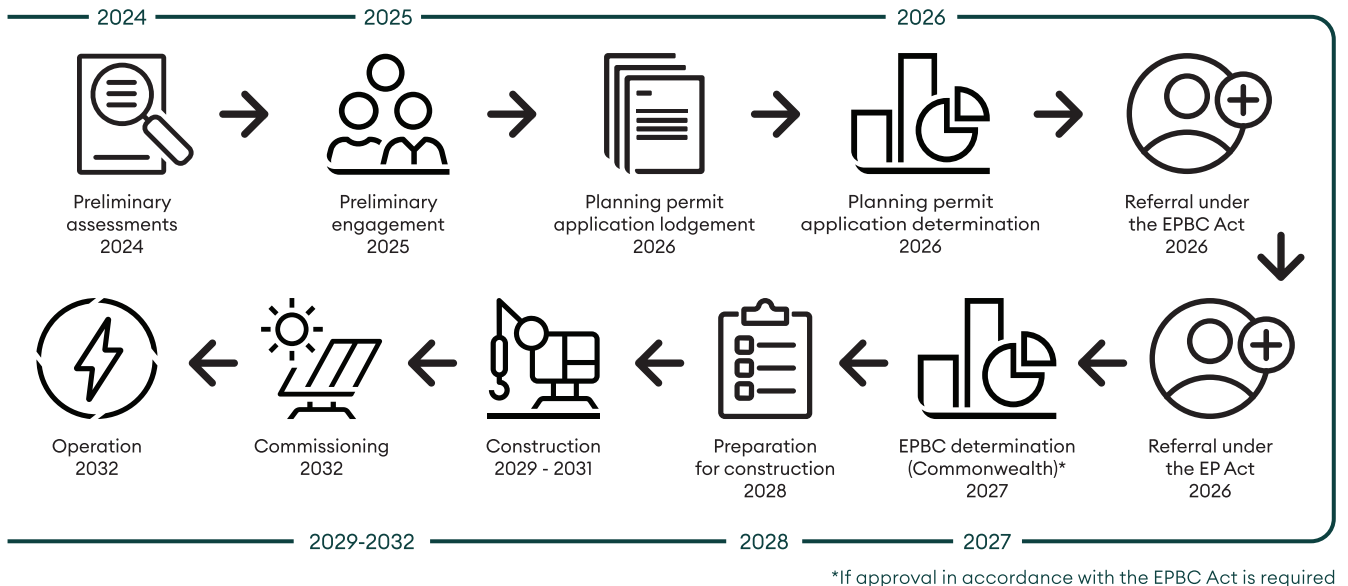
Community Engagement

OX2 is committed to collaborating with the local communities, Council and Traditional Owners to understand community views and aspirations and to design a community benefit program that drives positive economic and social outcomes while providing lasting value. Community engagement activities will begin in late 2025 and continue throughout the Project's life.

Project Status

We are currently in the early stages of the Project's development. Subject to local, state and Commonwealth planning and environmental approvals and grid connection agreements, construction is expected to commence in 2029 and operations are expected to begin in 2032.

The estimated timeline for the Project's lifecycle includes the following key phases:



Planning Approval Process

OX2 will be seeking a planning permit under the *Planning and Development Act 2005* and referring the project in accordance with *Section 38 of the Environmental Protection Act 1986 (WA)* (EP Act).

The Project will also be referred to the Department of Climate Change, Energy, the Environment and Water under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) to understand whether Commonwealth approval is required.
