We strive to achieve this by demonstrating good leadership, commitment, and continual improvement.

OX2 works actively to protect and promote the physical, psychological, safety, health, and wellbeing of our employees through the following activities:

- Complying with all legal and other relevant health and safety related regulations and requirements
- Identifying and monitoring risks and other hazards and sharing knowledge about risk prevention, while following the hierarchy of controls (elimination, substitution, engineering controls, administrative controls, and personal protective equipment) in managing risks
- Reporting incidents and observations to reduce risks and learn from experience
- All accidents and severe near misses will be investigated, and the knowledge and solutions will be shared in the company
- Cooperating with employees and safety representatives, as well as other key stakeholders, concerning health and safety aspects
- Developing the leadership, safety culture and awareness of health and safety issues
- Promoting a healthy psychosocial work environment by supporting mental and emotional well-being through initiatives such as, flexible work solutions, mindfulness, engagement surveys and inclusion, while encouraging all employees to contribute to psychological safety and a supportive culture
- Establishing health and safety improvement goals and monitoring their progress
- Ensuring strong contractor health and safety oversight, including prequalification

- assessments, ongoing health and safety performance monitoring, and enforcement mechanisms
- Continued health and safety training and education of our employees, including emergency preparedness and response plans to ensure readiness for potential incidents
- Providing access to occupational health services and appropriate health support, such as health checks and fitness-for-work assessments, when relevant
- Developing an effective use of the health and safety management system

Success at OX2 requires prioritizing both financial and sustainability targets, including the target to be a leader in health and safety. We are committed to creating a work environment that values the health, safety and well-being of our employees and people who work on behalf of OX2.
